2020 Data Requirements and Change Control Document

Section 1 - 2020 Data Requirements

Under Subsection 19-70 (1) of the [Higher Education Support Act 2003 \(HESA\)](#), a higher education provider must give to the Minister such statistical and other information that the Minister by notice in writing requires. This document provides details of the 2020 Higher Education Data Collection, including links to relevant documents, and change control information.

The Higher Education Data Collection incorporates:

- the Higher Education Student Data Collection (Table A, B, C providers and approved providers under section 16-25 of HESA);
- the Higher Education Staff Data Collection (Table A and B providers only); and
- the University Applications and Offers Data Collection (Table A and B providers only).

As stated in the Notice, providers must check for any changes to the data requirements to these collections which may be made from time to time. All changes will be noted in Section 2 and 3 of this document. Providers will also be provided notification of changes through the HEIMS Data Collections eNews at <https://heimshelp.education.gov.au/resources/heim-data-collections-eneews>.
